Message from President Morgan: So Where are all the pitchers? So far we are down eleven pitchers from last year at this same date. Each winter court this year does have propane heaters(Crossville and Morgan's) and one January tournament has been cancelled due to weather/driving conditions. Things are getting warmer so I hope the number of pitchers will increase. We only have three (3) more tournaments left before we have an outside event in Clarksville on Mar 25th.

2017 Charter sanction cards: So far 47 members have purchased a 2017 cards. Their color is PINK. TD's will be checking, you must have a card to pitch and can purchase one at any tournament at check in. Cost: \$25.00 (adult) \$10.00 (Juniors). If you are changing pitching category you must pitch qualifying number of shoes prior to the tournament. Make arrangements with the TD's or an officer.

Clarksville Court Update: Montgomery County is just about a month away from the covering of half of the Clarksville courts as promised late in the season last year. The contract and supplies are on their way. The estimated date to have 1/2 of the total courts covered is projected for March 2017 and hopefully done in time for the March 25th tournament. This should help for those concerned with any rain problems during this season and help with the heat and sunshine this summer. Be sure to contact Tournament director Ronnie Boyd if you have any questions. Updates will continue as they develop.

Contact your tournament Directors: Please call or email a tournament director prior to Friday at noon if you intend to pitch. This will allow them to get started on set up before the time of check in and should get tournaments started quicker. You will still be able to arrive at check in time and pitch if not already pre-registered. If you contact a TD and then can't come, call to make changes.
